

IDA TOWNSHIP BOARD REGULAR MEETING
July 6, 2021

The Meeting of the Ida Township Board was called to order at 7:00 P.M. with the Pledge of Allegiance to the Flag. Members present were Supervisor Paul Metz, Treasurer Kelly Elmer and Trustee Tim Mata. Also in attendance were Building Inspector Dave Friend and Fire Chief Kirt Horn.

Public Comment: None.

Approval of Agenda: A motion to approve the Agenda was made by K. Elmer with support by T. Mata. Motion carried.

Approval of Minutes: The Minutes of the Township Board Meeting held June 1, 2021 were reviewed. A motion to approve the Minutes was made by T. Mata with support by K. Elmer. Motion carried. The Minutes of the Special Meeting on June 24, 2021 were reviewed. A motion to approve the Minutes of the Special Meeting was made by P. Metz with support by T. Mata. Motion carried.

Building Department: The Building Department Report was presented by Dave Friend. There were 30 permits issued for a total of \$6793.00. There were 3 new home builds in the month of June.

Zoning Department: D. Friend reported that the Mudge project is moving along well.

Fire Department Report: The Fire Department report was reviewed. In June 27 calls were made in Ida, 20 calls in Raisinville and 1 call in Dundee for a total of 48 calls. There have been 303 calls so far this year. Chief Horn reported that he would like to have part time firefighters at the station between 8am-5pm by October 1, 2021.

Treasurer Report

K. Elmer reported that the CD's for the cell towers had been renewed.

Supervisor Report

P. Metz reported that he had contacted Bliss Nursery about Memorial Trees for the park. His hope is to plant 20 new trees in the park with the help of the Boy Scouts.

P. Metz mentioned looking into an ordinance on how the township will deal with resident's trees that need to be trimmed by licensed contractors. He will contact the Road Commission about the issue.
