The Meeting of the Ida Township Board was called to order at 7:00 P.M. with the Pledge of Allegiance to the Flag. Members present were Supervisor Paul Metz, Treasurer Kelly Elmer, Trustee Tim Mata and Trustee Chris Curry. Also in attendance were Fire Chief Kirt Horn and Librarian Suzanne Kreuger.
